Northbound (from Tacoma, Olympia, Long View, Renton, Oregon, SeaTac...etc) to the address:

- Follow I-5 South
- > Take exit **164A** for **Dearborn St** toward **James St/Madison St** 1.1 m
- Follow signs for I-5 N/Vancouver B C/Madison St/Convention Center 0.1 mi
- ➤ Keep right at the fork, follow signs for Madison St/Convention PI and merge onto 7th Ave 0.3 mi
- ➤ Turn left onto **Madison St** 0.3 mi
- > Turn left onto **2nd Ave** 148 ft

Destination will be on the right. Address: 915 2nd Ave Seattle, WA 98174.

Southbound (from Everett, Lynnwood, Woodinville, Edmonds, Canada,...etc) to the address:

- Follow I-5 North
- Take exit 165A toward James Street 0.3 mi
 Merge onto 6th Ave 157 ft
- Turn right onto **Columbia St** 0.1 mi
- > Turn right at the 2nd cross street onto **4th Ave** 0.1 mi
- > Turn left at the 2nd cross street onto **Madison St** 0.1 mi
- Take the 2nd left onto 2nd Ave 148 ft

Westbound (from Bellevue, Redmond, Issaquah, Bothell...etc) to the address:
